Westland Construction ("Respondent") is a "person," within the meaning of Section 502(5) of the Clean Water Act (Act), 33 U.S.C. § 1362(5), and 40 C.F.R. Part 122.2.

Attached is an Expedited Settlement Offer Deficiencies Form (Form), which is incorporated by reference. By its signature, Complainant (EPA) finds that Respondent is responsible for the deficiencies specified in the Form.

Respondent failed to comply with its National Pollutant Discharge Elimination System (NPDES) storm water permit issued under section 402 of the Act, 33 U.S.C. § 1342.

EPA finds, and Respondent admits, that Respondent is subject to section 301(a) of the Act, 33 U.S.C. § 1311(a), and that EPA has jurisdiction over any person who discharges pollutants from a point source to waters of the United States. Respondent neither admits nor denies the deficiencies specified in the Form.

EPA is authorized to enter into this Consent Agreement and Final Order (Agreement) under the authority vested in the Administrator of EPA by section 309(g)(2)(A) of the Act, 33 U.S.C. § 1319(g)(2)(A), and by 40 C.F.R. Part 22.13(b). The parties enter into this Agreement in order to settle the civil violation(s) alleged in this Agreement for a penalty of \$7,200.00. Respondent consents to the assessment of this

penalty, and waives the right to: (1) contest the finding(s) specified in the Form; (2) a hearing pursuant to section 309(g)(2) of the Act, 33 U.S.C. § 1319(g)(2); and (3) appeal pursuant to section 309(g)(8), 33 U.S.C. § 1319(g)(8).

Additionally, Respondent certifies, subject to civil and criminal penaltics for making a false statement to the United States Government, that any deficiencies identified in the Form have been corrected. Respondent shall submit a written report with this Agreement detailing the specific actions taken to correct the violations cited herein.

Respondent certifies that, within ten (10) days of receiving notice from EPA that the Agreement is effective (the effective date is thirty (30) days from the date it is signed by the Regional Judicial Officer), Respondent shall submit a bank, cashiers or certified check, with case name and docket number noted, for the amount specified above payable to the Treasurer, United States of America, via certified mail, to: U.S. Environmental Protection Agency Fines and Penalties RING CLERK Cincinnati Finance Center P.O. This Agreement settles EPA's civil penalty claims against Respondent for the Clean Water Act violation(s) specified in this Agreement. EPA does not waive its rights to take any enforcement action against Respondent for any other past, present, or future civil or criminal violation of the Act or of any other federal statute or regulation. EPA does not waive its right to issue a compliance order for any uncorrected deficiencies or violation(s) described in the Form. EPA has determined this Agreement to be appropriate.

This Agreement is binding on the parties signing below and effective thirty (30) days from the date it is signed by the Regional Judicial Officer, unless a petition to set aside the Order approving this Agreement is filed by a commenter pursuant to section 309(g)(4)(C) of the Act, 33 U.S.C. § 1319(g)(4)(C), or a hearing is requested under section 309(g)(4)of the Act, 33 U.S.C. § 1319(g)(4).

PUBLIC NOTICE OF PROPOSED COMBINED COMPLAINT AND CONSENT AGREEMENT AND OPPORTUNITY TO COMMENT

Summary: The EPA is providing notice of the opportunity to comment on a proposed Expedited Settlement Agreement (Agreement). The Agreement settles allegations by the EPA that Westland Construction, has violated a permit issued pursuant to the Clean Water Act (CWA) (permit number UTR374839) at the Provo High School construction project in Provo, Utah.

Background: The EPA alleges that Westland Construction has failed to have a complete and updated stormwater pollution prevention plan (SWPPP), failed to have inspections conducted by qualified personnel, failed to implement and maintain required stormwater controls, failed to post complete notice of permit coverage, and failed to minimize discharges of sediment and other pollutants into waters of the United States. Westland Construction has agreed to pay a civil administrative penalty of \$7,200 to resolve its civil penalty liability for these alleged violations.

The addresses of the EPA and Westland Construction are listed below.

<u>EPA</u>: EPA Region 8, 1595 Wynkoop Street, Denver, Colorado, 80202-1129. The EPA is identified in the Agreement as the Complainant.

The EPA is authorized by section 309(g) of the CWA, 33 U.S.C. § 1319(g), to issue an order assessing a civil administrative penalty for violations of certain CWA requirements, after providing (1) an opportunity for the person to be assessed the penalty to request a hearing to contest the penalty, and (2) notification to the public of its rights to submit written comments and to participate in any hearing.

PUBLIC COMMENTS

The EPA encourages the public to comment on the Agreement. The EPA will accept comments at the address listed below for a period of thirty (30) days after the publication of this notice. Any person submitting written comments has a right to participate in a hearing, if one is held.
