I. STATEMENT OF PURPOSE

1. This Addendum modifies the Finding of Violations and Administrative Order (Order) issued December 20, 2010 concerning the failure by the Anderson County Rural Water District #1C, located in Mound City, Kansas, with a Public Water System (PWS) identification number KS2000311, to collect TTHM and HAA5 dual sample sets in accordance with 40 C.F.R. § 141.601 and to submit to EPA Region 7 by July 1, 2010, its Initial Distribution System Evaluation Report pursuant to 40 C.F.R. § 141.600(c)(1). The Order as issued correctly identified the Respondent PWS by its PWS identification number of KS2000311, but it incorrectly named the Respondent PWS in both the caption and Paragraph 2 of the Order as “Anderson County Rural Water District #1” instead of as “Anderson County Rural Water District #1C.” This Addendum corrects this error.


II. CORRECTIONS
