Pursuant to paragraph 22 of the Administrative Order (AO) issued May 5, 2008 to the Fairway Estates Homeowners Association, this Addendum #3 to the AO incorporates the schedule for completing system modifications as outlined in the September 10, 2009 email from you on behalf of the Fairway Estates Homeowners Association to EPA. This letter constitutes the written approval by EPA of the Fairway Estates Homeowners Association planned actions as indicated in the chart below.

Please be advised that the Fairway F-states Homeowners Association must continue to sample quarterly for arsenic and provide quarterly public notice of the arsenic maximum contaminant level (MCL) violations as long as the running annual average exceeds 0.010 milligrams per liter (mg/l). Also, the Fairway Estates Homeowners Association must provide quarterly updates on the progress made towards bringing the water system into compliance with the arsenic MCL and notify EPA after all improvements required by the plan have been completed as required in paragraph 23 of the AO.
