this Motion, the parties note the following:

EPA filed its Complaint in this matter on September 24, 2008. On October 20, 2008, Unelko moved to extend the time to answer to December 15, 2008. EPA did not object to the request. On October 24, 2008, Unelko's request was granted.

On October 10, 2008, EPA issued two Stop Sale Orders against Unelko. Those Stop Sale Orders remain in effect.

EPA filed an Amended Complaint on November 17, 2008. Respondent's Answer to the Amended Complaint is currently due December 15, 2008. The parties request an extension of Unelko's time to answer the Amended Complaint to December 30, 2008, in order to allow time for consultation among counsel on a possible resolution of this matter.

Counsel for Respondent and EPA have been involved in extensive discussions regarding settlement of the claims underlying this action and have reached a settlement in principal of this

matter. However, Counsel for Respondent and EPA agree it is unlikely that the settlement will be finalized by December 15, 2008, the current deadline for filing of Respondent's Answer.

Counsel for Respondent has discussed this Motion with EPA. Counsel for EPA joins in this request for an extension of time.


