**SUPPLEMENTAL SETTLEMENT STATUS UPDATE**

Complainant United States Environmental Protection Agency, Region 8, by and through its undersigned attorney, provides the following Supplement to its Settlement Status Update previously filed in the above-referenced matter on June 13, 2014, pursuant to the PREHEARING ORDER issued by the Honorable Christine D. Coughlin, Administrative Law Judge, dated May 15, 2014.

1. On June 20, 2014, the undersigned on behalf of the Complainant and Mr. Mykel Stockton on behalf of Respondent Stockton Oil Company spoke regarding whether it was in the parties' mutual best interests to attempt to resolve this matter outside of hearing.

2. The parties further discussed whether to initiate settlement discussions between themselves or seek the assistance of a neutral by submitting a joint motion to initiate the Alternative Dispute Resolution (ADR) process.

3. The parties prefer to negotiate directly with one another rather than engage in ADR to attempt to resolve this matter. The parties have scheduled an initial settlement discussion for Wednesday, June 25, 2014.

4. Pursuant to the Order, the Complainant's prehearing exchange filing deadline is June 27, 2014.

5. Complainant plans to file with the Respondent's consent a motion on June 23, 2014, requesting a stay of the prehearing exchanges set forth in the Order for a specified time while the parties attempt to reach an amicable resolution of this matter without expending significant amounts of time and financial resources.
