Re: EPA Docket No. CWA-03-2021-0053DN AMENDED ADMINISTRATIVE ORDER ON CONSENT FOR WASTEWATER TREATMENT PLANT

Dear Mr. Baldwin, Mr. Blake and Mr. Sayre:

Attached is the executed Amended Administrative Order for Compliance on Consent ("Amended AOC") concerning violations of the Clean Water Act ("CWA"), as amended, 33 U.S.C. § 1251, et seq. The United States Environmental Protection Agency ("EPA") is issuing this Amended AOC to the City of Martinsburg ("the City") under the authority of Section 309(a) of the Clean Water Act ("CWA" or "Act"), 33 U.S.C. § 1319(a), for alleged violations related to the Wastewater Treatment Plant ("WWTP"). The AOC requires the City to submit certain documents to EPA and implement certain activities in order to meet the requirements of NPDES Discharge Permit No. WV0023167 (hereinafter, "WWTP Permit").

The Original AOC required the City of Martinsburg to:

(1) Propose, for EPA review and approval, a Corrective Action Plan ("CAP") which meets the requirements set forth in this AOC, and when implemented, will achieve certain milestones within the timeframes outlined in the AOC;

Customer Service Hotline: 1-800-438-2474 (2) Submit, for EPA review and approval, a Preventative Maintenance Plan ("PMP") which details the specific preventative maintenance requirements for each primary treatment, secondary treatment, and disinfection process or other equipment critical for optimal plant operation.

The new provision in the Amended AOC require the City to improve proper operation and maintenance of the facilities in Respondent's wastewater conveyance system by implementing the "Creekside/Maple Avenue Sewer Line Remediation Project," and completing this Project by August 31, 2022. The Creekside/Maple Avenue Sewer Line is currently located on the west side of Tuscarora Creek and is deteriorating in places. The City will relocate and rebuild a portion of this sewer line, in order to reduce the risk of a discharge to Tuscarora Creek.

Please note that the effective date of the Original AOC was August 6, 2021. The effective date of the amendment, located in Paragraph 48 of the Amended AOC, is today, the date of your receipt of this document.
