Attached (in .pdf format) please find the time-stamped Expedited Settlement Agreement (“ESA”) and Final Order in the above-captioned matter. The ESA and Final Order resolve P1 Performance, Inc. and JE Import Performance, Inc.’s violations of Section 203(a)(3)(B) of the Clean Air Act, 42 U.S.C. § 7522(a)(3)(B), and the implementing regulations found at 40 C.F.R. § 1068.101(b)(2), regarding the prohibitions against the manufacture, sale, offering to sell, or installation of aftermarket parts, components or defeat devices. These documents were filed today with the Regional Hearing Clerk.

In accordance with the terms and provisions specified in the ESA, you must timely pay the agreed civil penalty in accordance with the payment schedule set forth in the ESA. The case name and case docket number should be noted on the payment and a copy of the associated check or electronic transfer instrument or receipt should be sent, via e-mail, simultaneously to the Regional Hearing Clerk ([R3\\_Hearing\\_Clerk@epa.gov](mailto:R3_Hearing_Clerk@epa.gov)) and to Parmatma Adhikari ([adhikari.parmatma@epa.gov](mailto:adhikari.parmatma@epa.gov)).

For your file, I am also enclosing a copy of a supporting memorandum from U.S. Environmental Protection Agency management to the Regional Judicial Officer.
