Counts are based on respondent's Information Request Letter response, as well as inspection information from NYC agencies. The following penalty figures are based on the EPA LBP Consolidated ERPP (August, 2010). Respondent reported 2015 income of > \$1.6 Million and reported 8 employees so the Firm Cert count was taken as significant extent. All other counts were taken as minor extent because work was done in vacant apartments.

Count 1: Failure to obtain Firm certification

Allegation: Violation of 40 C.F.R. § 745.89(a)

<u>Evidence</u>: EPA's Information Request Letter (IRL) to Respondent asked, "Has your firm obtained certification from EPA to perform "renovations" as defined in 40 CFR 745.83?" Respondent answered, "No". Additionally, a search of EPA's Federal Lead-Based Paint Program (FLPP) finds no listing for A & I Developers. In their response to the IRL, A&I Developers indicated that 8 people are employed by the firm.
