Attached is the executed Federal Facility Compliance Agreement (FFCA) concerning violations of Section 301 of the Clean Water Act, 33 U.S.C. § 1311. The United States Environmental Protection Agency (EPA) Region 3 is issuing this FFCA to the United States Department of the Navy (Navy) under the authority of Section 309(a) of the Clean Water Act, 33 U.S.C. § 1319(a), for alleged violations at the Washington Navy Yard located in Washington, District of Columbia.

The FFCA requires the Navy to perform several tasks to return to compliance. These are listed in Section V (Compliance Program) of the FFCA.
