COMPLAINANT STATUS REPORT

Complainant hereby provides the Court with its Status Report for this civil administrative action pursuant to the Orders of the Court, dated October 27, 2011, and November 18, 2011.

1. The parties failed to meet to discuss this action or its potential settlement, and in clear violation of the Orders of the Court.
2. On November 18, 2011, Complainant and Respondent agreed to meet at 3:00 p.m. on Friday, December 2, 2011. Ms. Brumfield stated she could not decide whether to hire an attorney to represent her in this action.
3. On or about November 25, 2011, a Mr. Timothy McClure contacted Complainant, alleged he was an attorney and former prosecutor, represented Ms. Brumfield in this action, but would not meet with Complainant by December 2, 2011, notwithstanding the Orders of the Court. Therefore, the parties failed to meet as required by the Orders of the Court.
4. Mr. McClure failed to provide Complainant with an office name, business address or telephone number, or any evidence Ms. Brumfield retained him to represent her in this action.

5. On or about December 5, 2011, Complainant called Ms. Brumfield, and provided a voice mail message which asked whether she in fact retained any attorney to represent her in this action.? She failed to respond.
6. Complainant will file its Prehearing Exchange on or before December 30, 2011, pursuant to the Orders of the Court.
