

Second Joint Motion for Extension of Alternative Dispute Resolution

On December 7, 2007, Chief Administrative Law Judge Susan L. Biro issued an order initiating Alternative Dispute Resolution (ADR) in the above referenced matter, and assigning Administrative Law Judge Spencer T. Nissen to act as neutral. On February 6, 2008, the ADR period was extended by order to March 6, 2008 at the request of the parties. Complainant, United States Environmental Protection Agency, Region 5, and the Respondent, Sunrise Electronics Inc., continue to discuss settlement in the ADR process and are encouraged by the results of ADR, which include a settlement offer made by Complainant on the date of the most recent ADR conference, February 27, 2008. Respondent is currently reviewing the offer, and the parties believe it would be beneficial to continue the ADR process. By this Motion, and pursuant to 40 C.F.R. § 22.18(d), Complainant requests that ADR be extended another 30 days. Respondent agrees to the joint filing of this Motion.
