# For violating section 312 of the Emergency Planning and Community Right-To-Know Act.

This Expedited Settlement Agreement is being entered into by the U.S. Environmental Protection Agency, Region 10, by its representative, Director, Office of Compliance and Enforcement and by **FedEx Freight Inc. Fife, Washington** pursuant to section 325 of the Emergency Planning and Community Right-To-Know Act, 42 U.S.C. §11045, and 40 C.F.R. §22.13(b).

## **ALLEGED VIOLATION**

The EPA alleges that Respondent, owner and/or operator of the facility at 2316 70<sup>th</sup> Ave. S. Fife, Washington (Facility), failed to timely submit a completed emergency and hazardous chemical inventory form (Tier I or Tier II form as described in 40 C.F.R. §370.25 and 40 C.F.R. Part 370, Subpart D) for 2011 as required by section 312 of EPCRA, 42 U.S.C. §11022, and 40 C.F.R. Part 370. Under section 312 of EPCRA, 42 U.S.C. §11022, and 40 C.F.R. Part 370, Respondent did not submit its 2011 Tier I or Tier II form by March 1, 2012, and its 2011 Tier I or Tier II form by March 1, 2012.

#### **SETTLEMENT**

EPA and Respondent agree that settlement of this matter for a penalty of **TWO THOUSAND DOLLARS** (\$2,000) is in the public interest. In signing this ESA, Respondent: (1) admits that Respondent is subject to the requirements of section 312 of EPCRA; (2) admits that the EPA has jurisdiction over Respondent and Respondent's conduct as alleged herein, (3) neither admits nor denies the factual allegations contained herein; (4) consents to the assessment of this penalty; and (5) waives any right to contest the allegations contained herein.

By its signature below Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that: (1) the alleged violation has been corrected, and (2) Respondent is submitting payment of the civil penalty with this ESA. Each party shall bear its own costs and fees, if any.

The civil penalty of **TWO THOUSAND DOLLARS** (\$2,000) must be paid by cashiers or certified check to the "Treasurer, United States of America."
