Dear Ms. Scott:

On December 14, 2009, the United States Environmental Protection Agency (EPA) issued an Administrative Order (Order), Docket No. SDWA-08-2010-0004, ordering the Beaverhead County Jackson Water and Sewer District (District) to comply with various regulations issued by the EPA under the Safe Drinking Water Act (SDWA), 42 U.S.C. §§ 300f - j26. Our records indicate that the District is in violation of the Order.

The following requirement is quoted from item 13 of the "Order" section on page 3 of the Order.

1.During each calendar quarter until a different monitoring frequency is determined by the State [of Montana], [the District] shall monitor the [Beaverhead Jackson public water system's] water for arsenic. 40 C.F.R. § 141.23. . . . [The District] shall report any violation of the arsenic monitoring requirements to EPA and the State within 48 hours. 40 C.F.R. § 141.31(b).

The District failed to monitor for arsenic during the fourth quarter of 2012. The District failed to report this violation of the arsenic monitoring requirements to the EPA and the State of Montana within 48 hours.

The following requirement is quoted from page two of a January 17, 2012, letter from the EPA that modified the Order. This requirement was also referenced in an EPA letter dated November 13, 2012.

2.The District must now also continue to sample quarterly for combined radium and submit the results to EPA and the Montana Department of Environmental Quality (DEQ) until notified otherwise by the DEQ.

The District failed to monitor for combined radium during the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> quarters of 2012.



The EPA is considering additional enforcement action as a result of the non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the order, and/or (2) a court injunction ordering compliance.
