Introduction: The Presiding Officer requested that the parties' attorneys provide an update on efforts to resolve this matter.

Status: Complainant's attorney volunteered to summarize the status of this case. In addressing the long delay between the date the Complaint was filed and Respondent's February 26, 2014 *Motion Requesting Additional Time to Submit an Answer to the Complaint* was filed, Complainant's attorney explained that there were three mayors of the Respondent municipality during that time and each mayor had new staff, resulting in a lack of continuity in addressing this matter. Complainant's attorney said she is currently actively involved in negotiations with Respondent's attorneys. Respondent's attorneys indicated that their client had proposed a SEP, and that they are confident that settlement will be reached in the near future. They also agreed to

keep EPA apprised of their client's progress in devising a SEP.

In addition, the Undersigned notes the filing of a *Notice of Appearance of Additional Counsel for Complainant* dated March 21, 2014. By this Notice, Complainant, with the concurrence of Respondent, requests that the Undersigned take notice of the appearance of Evelyn Rivera-Ocasio as co-counsel to the attorney of record for the Complainant, Héctor L. Vélez Cruz.

The parties agreed that it was in the best interest of all parties to schedule a follow up status teleconference to apprise the Undersigned of their progress in resolving this matter. In light of the facts set forth herein, the Undersigned issues the following **ORDER**.
