Pursuant to the Presiding Officer's Prehearing Order dated September 10, 2010, and Sections 22.5, 22.7, and 22.16 of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits" ("Rules of Practice"), the United States Environmental Protection Agency, Region 10 ("Complainant" or "EPA") hereby moves to extend the times for filing of Respondent's Prehearing Exchange and Complainant's Rebuttal Prehearing Exchange for good cause as described below.

Complainant filed its Initial Prehearing Exchange on November 5, 2010, with the Regional Hearing Clerk. Copies were served on the Presiding Officer by pouch mail<sup>1</sup> and on Respondent, who is representing himself in this matter, at his home, by U.S. certified mail, return receipt requested. *See* Certificate of Service attached to Complainant's Initial Prehearing

Exchange and Notice of Appearance and Notice of Substitution, attached as Exhibit A.

According to the "Track & Confirm" information provided by the U.S. Postal Service's web site,

attached as Exhibit B, the Respondent's package was received at the Respondent's local post

office on November 11, 2010, and a notice was left with Respondent on November 12, 2010.

Respondent states that the notice was never received. In any event, the package was not received

by Respondent until Complainant tracked the package, unclaimed, at the post office and notified

Respondent on December 8, 2010. Respondent confirms that he claimed the package at the post

office on December 8, 2010.

Pursuant to the Presiding Officer's Prehearing Order and Section 22.7 of the Rules of

Practice, Respondent's Prehearing Exchange was due on December 8, 2010, including the five

days allowed to be added when service is by first-class mail. Since Respondent did not receive

Complainant's Prehearing Exchange until December 8, 2010, Complainant proposes that

Respondent's Prehearing Exchange be due on January 7, 2010, and that Complainant's Rebuttal

Prehearing Exchange be due 14 days after Respondent's Prehearing Exchange is filed with the

Regional Hearing Clerk, thus generally preserving the intervals originally provided in the

Presiding Officer's Prehearing Order. Complainant has consulted with Respondent concerning

the revised times, and Respondent concurs with the proposed new schedule.
