### **NOTICE OF ERRATA**

Complainant, the United States Environmental Protection Agency ("EPA" or the Agency), through the undersigned attorney to hereby provide notice of errata and correction as follows:

On September 30, 2015, Complainant filed a Complaint against Respondent Atlantic County Utilities Authority. Respondent filed an answer and request for a hearing on November 22, 2015. Complainant has learned that there are two minor errors in the description of the gravity portion of the Proposed Civil Penalty section of the Complaint:

- 1) Under count 1, EPA misstated: "EPA has determined that a failure to calibrate monitoring equipment properly is a violation of the monitoring requirement." The statement will be corrected to read: "EPA has determined that a failure to meet instrument specifications and zero gas requirements is a violation of the monitoring requirement."
- 2) Under count 2, EPA misstated: "EPA has determined that a failure to calibrate monitoring equipment properly is a violation of the monitoring requirement." The statement will be corrected to read: "EPA has determined that a failure to conduct the performance evaluation of LDAR equipment as required is a violation of the monitoring requirement."

The above referenced errors and proposed corrections do not affect the substance of the Complaint, because the violations as well as the factual and legal basis supporting them are described correctly throughout the Complaint. Therefore, even with the errors, Respondent was given full notice of the specific violations for which it is cited, the amount of the total penalty sought, and the statutory and regulatory basis supporting Complainant's penalty calculation.
