- 1. On August 7, 2007, Complainant filed a Status Report that requested an additional 30 days to file its Prehearing Exchange, due to the fact that the Respondent needed more time to obtain the requisite information from its supplier in order for Region 5 to approve Respondent's proposed SEP. Judge Gunning granted the 30 day extension to both parties.

- 3. Region 5 has now approved the SEP, and the CAFO is going through initial signoff at Region 5. Respondent will be out of the country until October 28, 2007 and will not be able to review the CAFO until that date.

WHEREFORE, Complainant respectfully requests an additional 30 days to file its Initial Prehearing Exchange, to November 20, 2007.
