JOINT MOTION FOR EXTENSION OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

Comes now Respondent Kmart Corporation and the U.S. Environmental Protection Agency, Region 2, by and through their undersigned counsel, and respectfully request a 60-day extension of the Alternative Dispute Resolution ("ADR") process. As grounds therefor, Movants state as follows:

- 1. On November 30, 2009, the Office of Administrative Law Judges sent a letter to the Movants offering to facilitate the settlement of this matter through the ADR process.
- 2. Both parties timely accepted the offer for ADR, and by letter dated December 9, 2009, Chief Administrative Law Judge Biro set a termination date for the ADR process of February 6, 2010. The same letter stated that an extension of up to 60 days may be granted upon request.
- 3. The Movants have since engaged in settlement negotiations and continue to work diligently toward resolution of this matter. The Movants believe that they may be able to resolve this matter without the assistance of an ADR neutral but may not have

it finally resolved before the ADR process terminates on February 6. Movants would like to preserve the option of engaging in ADR if settlement cannot be reached on their own by extending the ADR period for sixty days after February 6, 2010.

WHEREFORE, for the foregoing reasons, Movants respectfully request that the ADR neutral request a 60-day extension of the ADR process, and the Chief Administrative Law Judge grant the request for a 60-day extension.
