ORDER RESCHEDULING HEARING

No prejudice will result from the hearing being postponed from its currently scheduled date. Therefore, the hearing in this matter is hereby rescheduled and will now begin promptly at 9:30 a.m. on Tuesday, January 4, 2011, continuing if necessary, on January 5-7, 2011, in Atlanta, Georgia. The parties will be notified of the exact location and of other procedures pertinent to the hearing when those arrangements are complete.

Further, in light of the postponement of the hearing, other prehearing dates are hereby rescheduled as follows:


Complainant shall next file a report on the status of settlement in regard to this matter on or before **August 15, 2010**.

The parties shall file their Joint Stipulations on or before **September 15, 2010**.

All pre-trial motions, such as motions to amend prehearing exchange, motions for subpoena, and motions in limine, must be filed on or before **October 15, 2010**.

Any prehearing brief shall be filed on or before Friday **December 16, 2010**.

All other deadlines and prehearing requirements previously set remain in effect.
