ORDER TO FILE STATUS REPORT

- 1. On or before October 25, 2010, Complainant shall file a report on the status of this matter, including, at a minimum, (1) a statement concerning whether the Complainant has been successful in completing service of the Complaint on the Respondent; (2) if Complainant has not been successful in completing service on the Respondent, Complainant's plan for completing service or otherwise bringing this case to conclusion; and (3) if Complainant has been successful in completing service on the Respondent, the date and method of service and the nature of the documentation establishing service, a statement concerning Complainant's intention to file a motion for default and, if applicable, the date Complainant expects to file its motion, a summary of recent contacts between the parties (without disclosing the substance of settlement negotiations), an assessment of whether this matter is likely to be settled, and, if applicable, a projected date for the filing of a consent agreement and final order.
- 2. If Complainant has a return receipt (green card) or other documentation showing that the

Complaint was successfully delivered to the Respondent, Complainant shall file such documentation with the Regional Hearing Clerk on or before <u>October 25, 2010</u>.
