I wanted to be sure you knew that I received your October 29th letter. I have been out of the office quite a bit over the last few weeks and apologize for not responding earlier. My clients and I expect to be able to respond to your settlement offer in the near future.

I also received a Notice and Order from Regional Judicial Officer Sutin. She directed me to confer with you to confirm a time and date you and I would both be available to have a conference call. I need to get back the Regional Hearing Clerk no later than Thursday, November 15, 2007, to let her know those times and dates.
