Dear Mr. Duvall:

This addendum to the Administrative Order which was issued July 11, 2007, to you as the owner and operator of the Craig Bar water system, incorporates the plans for treatment and modifications as laid out in the plans and specifications provided by Jim Taylor, PE of Tech-neT, Ltd., on behalf of the Craig Bar water system. These plans and specifications were approved by the Montana Department of Environmental Quality on October 26, 2007. This letter also serves as an acknowledgement of the agreed upon time frame for monitoring for total coliform, nitrate, and issuing public notice as set forth in the October 10, 2007 conversation between Thomas Sitz and Kimberly Pardue Welch of EPA and your attorney Kristi Blazer on behalf of Craig Bar. The new deadlines reflect the fact that Craig Bar has been closed since August 30, 2007.

This letter constitutes the written approval by EPA of the schedule set forth in this letter. The effect of today's approval is to incorporate the following schedule into the Administrative Order. Each deadline in the schedule will be enforceable as if it were part of the Administrative Order itself. Please be aware that Craig Bar continues to be responsible for all requirements of the EPA Administrative Order as well as State and local requirements.

The following schedule lists the action to be taken, deadline date, and completion date if applicable.

Action	<u>Deadline</u>	Completion
Submit to EPA and the State detailed plans for providing continuous chlorination and required well improvements	August 11, 2007	October 9, 2007
Compete the installation of continuous disinfection and all required well improvements according to the approved plans and specifications	Prior to reopening Craig Bar	November 1, 2007
Submit a written certification to EPA and the State that all improvements have been completed	Within 10 days of completion	
Monitor water for total coliform	Within two weeks of reopening Craig Bar (November 15, 2007) and monthly thereafter	*
Monitor water for nitrate	Within two weeks of reopening Craig Bar (November 15, 2007) and quarterly thereafter	
Monitor and record the chlorine residual each day using an accepted DPD colorimetric test kit and maintain at least 0.2 mg/L free chlorine residual at all times	Begin daily monitoring as soon as the System obtains the colorimetric test kit but no later than two weeks of reopening Craig Bar (November 15, 2007)	
Issue public notice for violations included in the Administrative Order.	Within two weeks of reopening Craig Bar (November 15, 2007)
