

JOINT MOTION FOR EXTENSION OF TIME TO FILE  
COMPLAINANT'S AND RESPONDENT'S PREHEARING EXCHANGE

Pursuant to Rule 22.7(b) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits, Complainant, the United States Environmental Protection Agency, Region VII (EPA), and Respondent, Learjet, Inc., jointly request an extension of time for Complainant and Respondent to file their respective Prehearing Exchanges. The parties propose an extension of an additional 21 days, to and including September 15, 2006, for Complainant to file its Prehearing Exchange. The parties further request that the remaining schedule in the Prehearing Order be extended by an additional 21 days. The purpose for this extension is to allow additional time for the approval of settlement of the matter by EPA's Office of Enforcement and Compliance Assurance and avoid the unnecessary time and expense associated with administrative litigation.

This motion is submitted prior to the due date of Complainant's Prehearing Exchange, is submitted in good faith, and will not cause prejudice to either party.


