
ORDER GRANTING MOTION TO EXTEND TIME

A Prehearing Order was issued in this matter setting a due date of March 11, 2011 for the parties to file a Consent Agreement and Final Order (CAFO) or for Complainant to file its Initial Prehearing Exchange, and a due date of April 1, 2011 for Respondent's Prehearing Exchange. Complainant submitted a Motion to Extend Time to File Prehearing Exchange ("Motion"), dated March 8, 2011, requesting a 30-day extension of time, until April 10, 2011, to file its prehearing exchange. .

The Motion states that the parties have reached a settlement in principle and need sufficient time to obtain all necessary signatures and approvals. The Motion states that Respondent does not oppose the Motion.

The Motion is hereby **GRANTED** for good cause. However, the due date for Respondent's prehearing exchange must also be extended. Where the parties have reached a settlement, it is appropriate to set the due date for both parties to file their prehearing exchanges simultaneously in the event the CAFO is not filed by that date.

Accordingly, the parties shall file the fully executed Consent Agreement and Consent Order (CAFO), or their prehearing exchanges, on or before **April 10, 2011.**




