

**UNOPPOSED MOTION FOR EXTENSION OF TIME
TO FILE AN ANSWER AND REQUEST FOR HEARING**

Pursuant to 40 C.F.R. §22.16 of the Consolidated Rules of Practice, respondent Revival Animal Health, Inc., by and through its counsel of record, hereby moves for a further extension of time of sixteen (16) days to and including December 17, 2007 to file an answer and request for hearing with respect to the Complaint and Notice of Opportunity for Hearing filed by the United States Environmental Protection Agency, Region VII (“USEPA Region VII”).

In support hereof, respondent would show (1) that the time currently prescribed for respondent to file an answer and request for hearing has not yet expired, said answer and request currently being due from respondent on or before Saturday December 1, 2007; (2) this is only the second extension of time requested by respondent to answer and request a hearing and is limited to sixteen days; (3) respondent’s counsel Richard L. Green has conferred with USEPA Region VII Assistant Regional Counsel Ms. Jennifer Trotter, who stated that USEPA does not oppose the additional extension of sixteen days to file an answer and request, and (4) due to the intervening Thanksgiving holiday, press of business, and the fact that respondent’s counsel has only recently been retained for this matter, the additional sixteen days is necessary for respondent to complete an initial review of this matter, explore possible resolution with USEPA, and complete an answer and request.
