

REPORT RECOMMENDING CONTINUATION
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

The Chief Administrative Law Judge's Order of October 21, 2009 provides that this alternative dispute resolution (ADR) process terminates December 21, 2009. The recommendation of this Report is that the ADR process be continued for another month, to January 21, 2010.
