## Dear David Yonamine and Dustin Hara:

Enclosed is a Complaint and Notice of Opportunity for Hearing concerning violations of the Federal Insecticide, Fungicide, and Rodenticide Act ("FIFRA"). Specifically, the complaint alleges that HIRO Systems Hawaii LLC violated FIFRA Section 12(a)(1)(A) by selling or distributing the unregistered pesticides, "HIRO Proprietary Blend Raw TEG", "HOCL Hypo-Chlorus Acid Eco-Friendly Sanitization Solution by Hiro", and "HIROCL Hypochlorus Acid Sanitization Solution"; violated Section 12(a)(1)(E) of FIFRA by selling or distributing the misbranded pesticides, "HIRO Proprietary Blend Raw TEG", "HOCL Hypo-Chlorus Acid Eco-Friendly Sanitization Solution by Hiro", "HIROCL Hypochlorus Acid Sanitization Solution", and "Clean Republic Disinfectant + Sanitizer", and one (1) misbranded pesticide device, "Side-Kik HOCL Generator"; and violated 12(a)(2)(L) of FIFRA by producing the pesticides, "HIRO Proprietary Blend Raw TEG", "HOCL Hypo-Chlorus Acid Eco-Friendly Sanitization Solution by Hiro", and "HIROCL Hypochlorus Acid Sanitization Solution" in a pesticide producing establishment not registered with the EPA. EPA will seek a civil penalty for these alleged violations.

You should be aware of the part of the Complaint entitled "Opportunity to Request a Hearing." You are required to respond to this Complaint within thirty (30) days of receipt of the Complaint. If you fail to file an Answer to this Complaint with the Regional Hearing Clerk within thirty (30) days of receipt, your failure shall constitute an admission of all facts alleged in the Complaint and a waiver of your right to a hearing. The proposed civil penalty shall become due and payable sixty (60) days after a final order is issued upon default.

Copies of the following rules, regulations, and guidance are included for your information: (1) the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties; (2) EPA's Enforcement Response Policy for the Federal Insecticide, Fungicide, and Rodenticide Act, dated December 2009; and (3) the Amendments to EPA's Civil Penalty Policies to Account for Inflation (effective January 15, 2022) and Transmittal of the 2022 Civil Monetary Penalty Inflation Adjustment Rule.
