
**COMPLAINANT MOTION TO POSTPONE HEARING**

1. On August 2, 2007, the Court scheduled the hearing for this action for November 27 and 28, 2007, in Minneapolis, Minnesota.
2. On November 2, 2007, the parties agreed to a settlement in principle to resolve this action without resort to hearing.
3. On November 16, 2007, the parties agreed to final terms and conditions for a Consent Agreement and Final Order (“CAFO”).
4. The parties need ten (10) to fifteen (15) business days to sign and file the CAFO with the Regional Hearing Clerk.
