

**WITHDRAWAL OF COMPLAINT WITHOUT PREJUDICE**

COMES NOW the Complainant, the United States Environmental Protection Agency (EPA), Region 4, and hereby withdraws, under 40 C.F.R. § 22.14 of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits," the Administrative Complaint in this matter dated May 7, 2009, without prejudice.

Section 22.14(e) of the Consolidated Rules permits a complainant, to "withdraw the complaint, or any part thereof, without prejudice one time before the answer has been filed." After the respondent has filed an answer, the Complainant may withdraw the complaint without prejudice upon motion granted by the Court. As of the date of this Motion, Respondent has yet to file an Answer in this matter. Complainant has determined that, in light of the injunctive relief performed by the new owners at the site and a number of other reasons, including incarceration of Respondent, withdrawal of this Complaint is appropriate. Therefore, I respectfully submit this withdrawal request.
