Dear Ms. Maples:

The Town of Brookhaven ("Town") received the U.S. Environmental Protection Agency's September 7, 2012 correspondence and attached Administrative Complaint, Findings of Violation, Notice of Proposed Assessment of an Administrative Penalty, and Notice of Opportunity to Request a Hearing (the "Complaint") on September 14, 2012.

The purpose of this letter is to request an extension of time to answer the Complaint. The Town respectfully requests a 60-day extension of time, until December 13, 2012, to serve an answer to the Complaint. The Town is hopeful that the parties can reach an agreeable settlement during this time period.

In furtherance of the possibility of settlement, the Town also requests an in-person informal conference concerning this matter. At such a conference, the Town would like to discuss the allegations of the Complaint, the Town's efforts to comply with the Agency's Administrative Order that was issued on September 16, 2011, and the possibility of completing a supplemental environmental project as a component of an overall settlement. Representatives of the Town are available to meet on October 16, 22 or 26. Please advise if any of these dates are acceptable.

Please note that I recently spoke with Kimberly McEathron of the Agency regarding this matter, and accordingly, I have copied Ms. McEathron on this letter request. I have also copied Kimberly Kramer, Esq. so she is aware of the Town's request.
