## REPORT RECOMMENDING CONTINUATION OF ALTERNATIVE DISPUTE RESOLUTION PROCESS

The Chief Administrative Law Judge's Order of October 18, 2012 provides that this alternative dispute resolution (ADR) process terminates December 17, 2012. The recommendation of this Report is that the ADR process be continued for another month, to January 18, 2013.

This continuation of the ADR process is recommended because the parties were unable to initiate settlement discussions as scheduled during the week of October 29, 2012 due to closures of EPA's Region 2 offices caused by Hurricane Sandy. The parties have tentatively rescheduled the canceled hearing conference for November 28, 2012. Given the scope and breadth of the Complaint, both parties anticipate a full four months will be needed to reach settlement.
