ORDER ON REQUEST FOR EXTENSION OF TIME TO FILE EXECUTED
CONSENT AGREEMENT AND FINAL ORDER

On March 28, 2011, the undersigned received a Status Report and Request for Extension of Time to File Executed Consent Agreement and Final Order ("Request") in which Complainant states that the parties have reached an agreement in principle dispositive of all matters, including a penalty and a Supplemental Environmental Project ("SEP"). Citing the complexity of the review and concurrence process within the EPA, Complainant requests sixty (60) days to finalize and execute a Consent Agreement and Final Order ("CAFO"). Complainant states that Respondent concurs in the filing of this Request.

A Prehearing Order has not yet been issued in this matter. However, given the progress of the parties towards reaching a settlement, the Request is hereby **GRANTED** for good cause shown. The parties have until **May 25, 2011**, to file a CAFO. If no CAFO is filed on or before May 25, 2011, a Prehearing Order will be issued with close deadlines for the parties' respective submissions.


