MOTION TO WITHDRAW COMPLAINT

Pursuant to 40 C.F.R. §§ 22.16 and 22.14(d), and for the reasons set forth and discussed herein Complainant United States Environmental Protection Agency ("Complainant" or "EPA"). hereby moves to withdraw the subject Complaint with prejudice.

A matter that has some bearing on this case has come to the attention of the Agency. This matter has been referred to the appropriate EPA investigative organization. The Complainant and Complainant's Counsel do not control or influence the conduct of this investigation. It is therefore not possible at this time to determine the outcome or duration of this investigation.

The June 23, 2011 Order denying Complainant's Motion to Stay Proceedings noted this Court's duty under 40 C.F.R. § 22.4c to "avoid delay" and to take measures necessary "for the efficient, fair and impartial adjudication of issues." Order at 2. The Order further directed that the Prehearing Exchange be submitted today, i.e., June 24, 2011. Due to the on-going investigation referenced above, Complainant has determined that it is not appropriate at this time to submit the Prehearing Exchange it had already prepared in this matter. Further, the indeterminate delay in this proceeding related to this investigation is likely to compromise the prospects for a speedy adjudication as contemplated by 40 C.F.R. Part 22. Therefore, with the understanding that Complainant may not be able to comply with a reasonable pre-trial schedule, EPA hereby moves this Court to withdraw the Complaint in this matter with prejudice.

Counsel for EPA contacted opposing Counsel's offices/chambers yesterday in order to determine their position on this Motion. In addition, Counsel for EPA contacted the office of Respondent Cararcio's Counsel via email. As of the time of the filing of this Motion, Counsel

Respondents have asserted that "[d]elay will prejudice the former trustee to obtain a prompt adjudication of the Complainant's averments against him without further delay." Respondent Zito's Answer to Complainant's Motion to Stay Proceedings at ¶ 4.
