Dear Mr. and Mrs. Stuard:

Pursuant to paragraph 16 of the Administrative Order (Order) issued January 25, 2011, to you as owners of the Bill Cody Ranch public water system, this Addendum to the Order incorporates the schedule for completing system modifications as outlined in your letter of March 30, 2011, to EPA. This letter constitutes the written approval by EPA of the District's schedule as indicated in the chart below.

Please note that EPA expects this approved schedule to be met. While not creating any right to an extension, EPA may in its discretion consider granting an extension to any deadline in the schedule under limited circumstances. If unexpected events occur that are beyond the system's control and that may prompt you to request an extension of these deadlines, the system will be responsible for notifying EPA well in advance of the deadline dates. EPA will not consider extending these deadlines without a clear justification for their need. You must provide the following information in any request for extensions: a description of the work that has been completed and the additional work that may not be completed by the deadline dates, the unexpected events that occurred and how Respondent attempted to foresee or overcome these obstacles, the proposed new deadline dates, and an explanation that justifies the new proposed deadline dates.

Seal spring box.	March 30, 2011	May 15, 2011
Construct a fence around the spring box to prevent wildlife access.	March 30, 2011	May 15, 2011
Clean fallen and growing vegetation around spring box.	March 30, 2011	May 15, 2011
Treat system at the beginning of each season	March 30, 2011	May 15, 2011

Consistent with paragraph 17 of the Order, the "Finish Date" deadlines above are now enforceable requirements of the Order. Further, EPA requests you forward photographs showing completion of the above action items, as appropriate.

Please be advised that you are required to comply with all provisions of the Order. Penalties for failing to comply are set forth in the Order.
