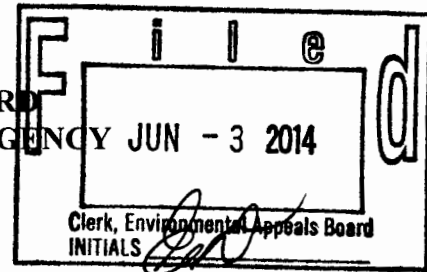

**ORDER TO PRODUCE DOCUMENT MISSING
FROM ADMINISTRATIVE RECORD**

On May 15, 2014, the Environmental Appeals Board ("Board") elected to review under its 40 C.F.R. § 22.30(b) authority, the Default Order and the associated Order on Respondent's Motion to Set Aside Default Order and Temporarily Stay Proceedings ("Order on Motion to Set Aside") that U.S. EPA Regional Judicial Officer Renée Sarajian ("RJO") issued in the above-captioned case. At the request of the Clerk of the Board, the Regional Hearing Clerk had sent to the Board on May 6, 2014, a copy of the administrative record for this proceeding accompanied by a certified index. Upon review of the administrative record, the Board has discovered that a key document is missing and is not listed on the certified index. This document, entitled Response to the Order to Show Cause and dated March 20, 2014, however, was cited and considered by the RJO in her decision. *See* Order on Motion to Set Aside at 3, 5, 7. The Board needs this document to perform a complete review of this case.

Accordingly, the Region is hereby ORDERED to file a copy of this document with the Board within seven (7) days of the date of this order. The Region is further ORDERED to add this document to the index to administrative record for this proceeding, to provide a new certification that the index is complete, and to provide an explanation as to why this document
