







WITHDRAWAL OF COMPLAINT



On December 19, 2019, the United States Environmental Protection Agency – Region 1 (“Complainant”) filed an *Administrative Complaint and Notice of Opportunity for a Hearing* (“Complaint”) in this matter pursuant to Section 113(d) of the Clean Air Act, 42 U.S.C. § 7413(d), and the *Consolidated Rules of Practice* (“Consolidated Rules of Practice”), 40 C.F.R. Part 22, against Exeter Scrap Metal, Inc.


