This is an Addendum to the Administrative Order (Order) issued on December 28, 2017, regarding the Potlatch Trailer Court Public Water System. The schedule is hereby incorporated into the Order per paragraph 9 (page 2) of the Order.

Production Well Construction Completion-New Well Online/Close-out	September 2018


You are required to provide the EPA with quarterly progress reports. Within 10 days after completing all tasks included in the schedule, you shall notify the EPA of the project's completion. You must achieve and maintain compliance with the nitrate MCL by the final date specified in the schedule. The EPA is authorized to seek penalties if these deadlines are not met. If you have a reasonable basis to believe you may be unable to meet any deadline in the schedule, you shall notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension.
