#### I. PRELIMINARY STATEMENT and STATUTORY AUTHORITY

- 1. This Consent Agreement and Final Order ("CAFO") is entered into by the Director, Water Protection Division, U.S. Environmental Protection Agency, Region III ("EPA" or "Complainant"), and the Borough of Tyrone ("Tyrone" or "Respondent"), pursuant to Section 309(g) of the Clean Water Act, 33 U.S.C. § 1319(g), and the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, and the Revocation, Termination or Suspension of Permits ("Consolidated Rules"), 40 C.F.R. Part 22. The parties have agreed that this CAFO resolves Complainant's civil claims pertaining to violations of Section 301 of the Clean Water Act, 33 U.S.C. § 1311, alleged in an administrative Complaint filed on June 30, 2010 ("the Complaint").
- 2. Pursuant to Section 309(g) of the Clean Water Act ("CWA" or "Act"), 33 U.S.C. § 1319(g), and the Federal Civil Penalties Inflation Adjustment Act of 1990, as amended by the Debt Collection Improvement Act of 1996, and the subsequent Civil Monetary Penalty Inflation Adjustment Rule, 40 C.F.R. Part 19, any person violating the CWA is liable for an administrative penalty under Section 309(g) of the Act. Violations occurring between March 15, 2004 and January 12, 2009 subject the violator to civil penalties in an amount not to exceed \$11,000 per day for each day the violation continues, up to a total penalty amount of \$32,500; violations of the Act that occurred after January 12, 2009 subject the violator to civil penalties in an amount not to exceed \$16,000 per day for each day the violation continues, up to a maximum of \$37,500.

#### II. FINDINGS OF FACT AND JURISDICTIONAL ALLEGATIONS

- 3. For purposes of this CAFO, Respondent neither admits nor denies the factual allegations contained in Paragraphs 9 through 24 of the Complaint.
- 4. Respondent admits the jurisdictional allegations contained in the Complaint.

This CAFO does not constitute a waiver, suspension, or modification of the requirements of the CWA, 33 U.S.C. §§ 1251, *et seq.*, or of any regulations promulgated thereunder.
- 16. The following notice concerns interest and late penalty charges that will accrue in the event that any portion of the civil penalty is not paid as directed:

Pursuant to 31 U.S.C. § 3717 and 40 C.F.R. § 13.11, EPA is entitled to assess interest and late payment penalties on outstanding debts owed to the United States and a charge to cover the costs of processing and handling a delinquent claim, as more fully described below. Accordingly, Respondent's failure to make timely payment or to comply with the conditions in this CAFO shall result in the assessment of late payment charges including interest, penalties, and/or administrative costs of handling delinquent debts.

Should assessment of the penalty charge on the debt be required, it shall accrue from the first day payment is delinquent. 31 C.F.R. § 901.9(d).

17. This Consent Agreement and the accompanying Final Order resolve only the civil claims for the specific violations alleged herein. EPA reserves the right to commence action against any person, including Respondent, in response to any condition which EPA determines may present an imminent and substantial endangerment to the public health, public welfare, or the environment. In addition, this settlement is subject to all limitations on the scope of resolution and to the reservation of rights set forth in Section 22.18(c) of the Consolidated Rules of Practice. Further, EPA reserves any rights and remedies available to it under the Clean Water Act, 33 U.S.C. §§ 1251, *et seq.*, the regulations promulgated thereunder, and any other federal laws or regulations for which
