It is used for companies of every size and sophistication that are making claims of an inability-to-pay a monetary penalty. We have inserted some information into this

template that is specific to Chill Transportation, LLC's circumstances, but some of the questions and requests for information may not be applicable to this situation. Eventually you will need to submit written responses to each of the questions and requests for information in the template in order to allow EPA's economist to fully review and assess Chill Transportation, LLC's ability to pay a monetary penalty. While the request for information may seem voluminous or overwhelming, I want to emphasize that Rick and I are committed to working with you to ensure that you fully understand the process and the information that EPA is seeking. In the simplest terms, EPA will need four categories of information from Chill Transportation, LLC: 1. income (what are you bringing in); 2) assets (what do you own); 3) expenses (what are you paying out to continue to operate); and 4) liabilities (what do you owe and what are your potential claims).
