Motion To Vacate Initial Decision and Default Order

Hello, I received an Administrative Initial Decision and Default Order concerning Well #54. The complaint states that I have violated the Safe Water Act for failure to plug Well #54.

On August 17, 2007 I took ownership of 2 Oil & Gas Mining Leases – S/2 SW/4 Section 15, T29N, 11E and SE/4 Section 16, T29N, 11E which has around 25 wells from both leases. On March 5, 2008 I was granted the authority to consolidate both leases and produce the oil production into one common tank on Section 16, T29N, 11E. On Section 15 some of the wells are divided by a river and I am only producing at this time the wells on Section 15 and 16 that are on the same side of river were my tank battery is located. I am currently producing **only 2 wells out of 25.**

**The Findings of your facts or inaccurate:**

On April 3, 2009 I wrote a letter to the BIA **accepting all well bores** on the 2 leases and stated that I **did not want any of them plugged.**

Well #54 is on the side of the river that I have **never** tried to produce any of the wells, operate, place any equipment on, and there is no tank battery on that side of the river. This well was not located by the EPA or the Osage Energy Department until August 24, 2012 and has **not been used or operated by me ever** and **not in over 15 years since its previous owners.** I **never accepted this well as an injection well and it has never been in use for my leases.**

There is no proof that this well is in violation or has ever been in violation of the "SDWA". I received 3 Inspection reports for Well 54 and all stated the inspection of this

**well identified no violations of the Osage Underground Injection Control Program:**

**August 30, 2012 – No Violations (Copy attached)**

**December 14, 2012 – No Violations (Copy Attached)**

**October 7, 2014 – No Violations (Copy Attached)**

The Public has never responded to any of these false complaints to date showing any violations of the "SDWA".

This penalty will cause great financial harm to my small business and I have not made \$7000 in oil production from these leases this year. I feel this order is reckless, a waste of time, taking advantage of a small operator with limited resources, and all the facts in this case or not accurate.

I do not consent to this Decision and Default order and this Administrative Order **should be closed immediately**. Well #54 was not in violation, its been untouched and not produced in over 15 years **with heavy vegetation all around it and proposes no threat**. Not only has it not been ever produced by me, it has not been produced in over 10 years before I took over the lease.
