Director of the Compliance Assurance and Enforcement Division, United States Environmental Protection Agency, Region 6 ("Complainant"), respectfully requests that the Regional Judicial Officer grant a 60-day extension of time for Jaime Oil, Inc. ("Respondent") to file its answer and request a hearing in the above-captioned matter. Respondent received the Complaint on May 18, 2015, so the due date for the answer and hearing request was June 17, 2015.

Complainant requests this extension for the following reasons:


1. Respondent has agreed to pay the full penalty amount of \$6,000.00 requested in the Complaint, and the Complainant has agreed that payment can be made in installments. Because Respondent cannot pay the full penalty immediately, the parties must draft a Consent Agreement and Final Order ("CAFO") memorializing the terms of settlement.

2. The parties fully expect swift resolution of this matter, but need time to draft the CAFO, route the CAFO through the internal EPA concurrence process, and achieve signature by both parties.
3. Requiring Respondent to compose and file an Answer at this time will not expedite resolution of this matter.

Accordingly, Complainant requests that the Respondent receive an extension to file an answer and request a hearing until August 17, 2015.

Complainant consulted Respondent in the preparation of this motion, and Respondent concurs.
