Dear Ms. Faye:

This letter notifies you that the proposed administrative settlement between the U.S. Environmental Protection Agency (EPA) and Blue Tee Corp. concerning the American Lead & Zinc Mill Site, Ouray, Colorado (Site), is now final and effective.

In accordance with Section 122(i) of the Comprehensive Environmental Response, Compensation, and Liability Act, as amended (CERCLA), 42 U.S.C. § 9622(i), EPA published in the Federal Register on August 2, 2013 (75 Fed. Reg. 46948), a notice and request for public comments on the proposed Administrative Settlement Agreement (Settlement Agreement) with Blue Tee Corp. for the Site. The notice provided for a 30-day comment period and opportunity for persons who are not parties to the proposed settlement to provide comments relating to the proposed settlement. The public comment period is now closed and EPA did not receive any comments on the proposed settlement. Thus, there are no facts or considerations that indicate that the settlement is inappropriate, improper or inadequate.

In accordance with Section XVI of the Settlement Agreement, the proposed settlement is effective on the date of issuance of this notice. The date of this notice shall be deemed the Effective Date of the Settlement Agreement.

A copy of the signed and filed Settlement Agreement is enclosed for your records. I also have enclosed a copy of EPA's interest calculation for this settlement.
