**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

By Motion dated January 27, 2010, Complainant moved for a two month extension of time to engage in the prehearing exchange. The Motion indicated that the Respondent had no objection to the extension requested.

The Motion is hereby, **GRANTED**, as set forth below:

Good cause exists for the granting of the Motion. The Motion indicates that the Respondent has raised a challenge to the factual predicate supporting many of the violations alleged and has agreed to provide the Agency with evidence in support thereof by February 5, 2010. Further, assuming the accuracy of such challenge, the parties have otherwise agreed to settle the case for a sum certain and evidence of current compliance requiring submission and review of documentation. In that a hearing in this case has yet to be scheduled, no prejudice will result from a brief delay in the prehearing exchange process. Therefore, the Complainant shall have until **April 19, 2010** to submit its initial prehearing exchange; Respondent shall have until **May 12, 2010** to submit his prehearing exchange; and Complainant shall have until **May 25, 2010** to submit its rebuttal prehearing exchange.
