Despite being made in an untimely filed Status Report and in improper form (i.e. not in a Motion), this request was granted by Order dated April 29, 2008. The Settlement Status Report did not request any extension of time for filing of the Complainant's Prehearing Exchange and none has been granted. To date, obviously, no Consent Agreement has not been filed either.
