The U.S. Environmental Protection Agency, Region 5, is providing this notice of its intent to enter an Administrative Order on Consent (AOC) with Koyl Oil, Inc. (Respondent). The AOC alleges Respondent failed to comply with federal regulations and requirements for its Underground Injection Control (UIC) permit listed below (the Permit) for its Class II disposal injection well facility in Michigan:

Lloyd Koyl 3-15 SWD (EPA No. MI-025-2D-0021), Calhoun County, Michigan

EPA has the authority to file the AOC under Section 1423(c) of the Safe Drinking Water Act (SDWA), 42 U.S.C. §300-2h. The AOC proposes that Respondent meet compliance requirements to improve the operation, monitoring, and recordkeeping practices of its injection well.

EPA alleges that the Respondent violated the Permit and the UIC regulations at Title 40 of the Code of Federal Regulations (40 C.F.R.) Part 144 by 1) failing to conduct the required weekly monitoring, 2) submitting inaccurate monthly monitoring reports, 3) failing to submit required annual reports of the chemical composition of the injectate, 4) failing to submit annual gauge calibration certificates, and 5) failing to maintain positive pressure on the annulus. To remedy these violations, Respondent will undertake the activities described in the AOC.

Monitoring and reporting of injection well is vital to protecting underground sources of drinking water because the required activities ensure that the well have mechanical integrity, are not leaking, and are being operated for the purposes for which they were permitted. Retaining accurate and complete records is necessary to help EPA make informed decisions, and validate reports submitted to the Agency.
