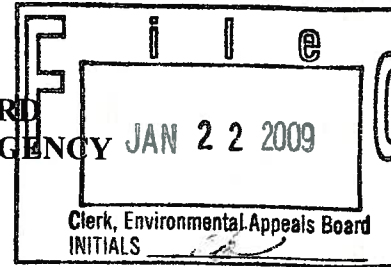

EARLIER MOTION**

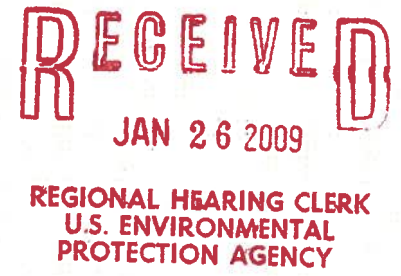
