### MOTION REQUESTING ADDITIONAL TIME TO ANSWER COMPLAINT

#### TO THE HONORABLE REGIONAL JUDICIAL OFFICER:

COMES NOW Respondent, Marina PDR Operations, LLC, Inc. ("Respondent"), through the undersigned attorneys, and respectfully alleges, prays and requests as follows:

- 1. On October 13, 2016, the Director of the Caribbean Environmental Protection Division, United States Environmental Protection Agency, Region 2 ("Complainant") filed an "Administrative Complaint, Findings of Violation, Notice of Proposed Assessment of and Administrative Penalty, and Notice of Opportunity to Request a Hearing (the "Complaint") in the above captioned matter against Respondent alleging it had violated the Clean Water Act at the Marina Puerto del Rey in Fajardo, Puerto Rico.
- 2. Respondent just recently retained the services of the undersigned attorneys to represent it in the captioned case. We respectfully inform the Regional Judicial Officer that we are currently reviewing and studying the Complaint and further investigating information in order to file an adequate and complete Answer to the Complaint and request a hearing, if deemed necessary.
  - 3. On October 25, 2016, attorney for Respondent telephoned attorney for

Complainant to schedule an informal settlement conference to possibly reach a settlement of the above captioned matter.

- 4. The informal settlement conference has been scheduled for November 9, 2016.
- 5. Depending on the informal settlement conference, Respondent expects to file an Answer to the Complaint, and Complainant has acquiesced to Respondent's request for additional time to file such Answer.
- 6. In light of the above, and that there is no undue delay, bad faith or dilatory motive that can affect either Parties' rights under law, and there is no prejudice or additional burden to Complainant, Respondent requests that it be granted, thirty (30) days from the filing of this motion to allow Respondent to file an Answer to the Complaint.
- 7. This motion was discussed with the attorney for Complainant, who has agreed to the filing of this motion and does not oppose the extension of time.
