MOTION FOR EXTENSION OF TIME IN WHICH TO ANSWER THE ADMINISTRATIVE COMPLAINT

Proceeding Under Section 309(g)(2)(B) of the Clean Water Act and Section 3008(a) of the Resource Conservation and Recovery Act

I. NEED FOR AN EXTENSION

On Monday, August 17, 2009, the City of Gardner ("Gardner") received the Administrative Complaint in the above-captioned matter. The City's deadline for filing an answer was initially extended to October 16, 2009. The City of Gardner has submitted a written plan for compliance with the EPA and attended a meeting to discuss settlement on September 8, 2009. The Parties have had a second settlement conference. The Parties continue to make progress toward settling this matter and the EPA has initiated an assessment of the City's ability to pay an administrative penalty.

This extension is necessary in order to continue to explore the possibility for settlement of this matter and to allow the City to provide the information necessary for the EPA to conduct the ability to pay assessment. In order to accomplish these tasks, the City is requesting a forty-five (45) day extension from October16, 2009 to file its Answer. The requested forty-five day extension should provide sufficient time to determine if a settlement is likely.

Legal counsel for EPA Region I, Kathleen Woodward, has indicated that she has no objection.

II. AUTHORITY TO GRANT AN EXTENSION

The Presiding Officer may grant an extension of time for filing any document, including a written answer to an administrative complaint, upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties, under the Consolidated Rules of Practice, 40 C.F.R. §22.7(b). This Motion is made in advance of the due date of September 16, 2009 to allow other parties to respond and to allow the Presiding Officer to issue an Order, especially in light of the assent by EPA counsel to issuance of the requested extension.

III. REQUEST FOR EXTENSION

Because there is no prejudice to any other party and there is good cause for an extension of time in which to file an Answer to the Administrative Complaint, the City of Gardner respectfully requests that the time for filing an Answer to this Complaint be extended until November 30, 2009.
