This email is to inform you of the United States Environmental Protection Agency's (EPA) decision to close the Emergency Administrative Order (Emergency Order) issued on March 22, 2019, to the **Oglala Sioux Rural Water Supply System and the Oglala Sioux Tribe Water & Sewer Company (Utilities).** The EPA has determined that the Utilities have completed all actions outlined in the Emergency Order and that the water provided by the Kyle Water System (System) no longer presents an imminent and substantial endangerment to persons served by the System. Therefore, EPA will close the Emergency Order at this time.

Please be aware that the Utilities are still required to comply with the National Primary Drinking Water Regulations (NPDWR), 40 C.F.R. part 141. Violation of the NPDWRs may result in a court-imposed injunction and penalties of up to \$53,907 per day of violation.
