The Combined Complaint and Consent Agreement ("CCCA") and Final Order in the captioned matter require BP America Production Company ("BP") to hire an engineering consultant to conduct a macroinvertebrate study ("Study") for the Rock Creek watershed. (Copies of the CCCA and Final Order are attached; see CCCA, paragraph 21.) BP hired Wright Water Engineers, Inc. ("WWE") to conduct the Study. The CCCA and Final Order also require BP to obtain and incorporate into the Study additional, relevant macroinvertebrate sampling data collected by the Southern Ute Indian Tribe ("SUIT"). WWE obtained and incorporated such SUIT data into the Study. Finally the CCCA and Final Order require BP to provide the United States Environmental Protection Agency, Region 8 and the SUIT Water Quality Program copies of a final report ("Final Report") highlighting the SUIT data and detailing the results and findings within sixty days of receiving the SUIT data. WWE received the SUIT data on November 19 and December 3, 2012. The Final Report is attached .
